### **1. Categories of personal data**

We hereby inform you that we collect, use and process the following categories of your personal data:

### **2. Legal basis and purpose (As per Article 6(1)(f) GDPR, we hereby inform you that we use your personal data for the purpose of providing you the following services.)**

- To operate and manage the World Sushi Cup® and website.
- To contact you regarding the registration procedure and selection result.
- To provide information related to this contest.
- To post registry information/challenge details/selection results on this website, SNS, the Ministry of Agriculture, Forestry and Fisheries home page as well as publishing in various other media outlets.
- To distribute the participant's list to the Contest delegates.
- To contact you for any other reasons that arise.

In addition, your personal data may be converted into statistical or aggregated data which cannot be used to identify you and then used to produce statistical research and reports. For purposes other than those stated above, World Sushi Cup® will not use your personal information.

### **3. Retention periods**

We keep your personal data as long as there is a statutory or legal requirement to do so or in order to provide the aforementioned services to you. For accounting or auditing purposes we may retain your personal data for a period of time after our direct business dealings have ended.
